The church is open Monday through Friday from 6:30am to 6pm or feel free to mail your registration papers back to us. **One form per child please.** See you in August!

Drop-off and Pick-up:

9am drop off in the turnaround parking lot. There will be parking attendants in orange vests to help guide you in. A volunteer will meet you at the car to check-off your children, confirm details of their registration and escort them to the registration desk where they will receive a name-tag, and a bracelet for anyone with food allergies. Kids will then join pre-games until worship begins at 9:15.

Please arrive promptly at 11:30. We must be cleaned-up and all equipment cleared off the premises by Noon when Bethany Vineyards business hour begin.

Code of Conduct: (These rules are essential for your child's safety. They must be followed in order for them to participate.)

Please stay with your assigned group at all times.

Please stay within the flagged boundaries at all times unless with a staff member.

Please do not walk in the garden beds or vineyards unless with a staff member.

Under no circumstances is anyone allowed in the on-site lake or on the floating dock.

The bandstand area (puppet stage) is for staff members only.

Tips to make the week successful:

- Please apply sunscreen to your child before arrival time.
- Please leave all electronics at home. Wi-fi signal is for staff only and cell coverage is weak. We have a landline for emergencies only. If you need to reach us, contact Krista.
- The parking lot is very small with limited spaces so its best to drop your child off, however, if you need to speak to the registrar or you have a change in pick-up routine please follow the signs to staff parking.
- We will offer water frequently. If you choose to send a water bottle, please label it with your child's name.
- If you're child has food allergies, a bee sting allergy, an epi-pen or you have any other concerns that we need to be made aware of please indicate it in the registration packet so that we can take the appropriate action.
- Children who need to eat from the alternative snack menu (see below) will be given an orange bracelet to wear so we can serve them appropriately.
- The children will be seated on the grass in front of the bandstand for the opening and closing sessions. If you're concerned about them sitting in the grass, please send them with a beach towel clearly labelled with their name. The towel will need to go home each night.
- We will have a volunteer firefighter on hand to render first-aid or to call for help if needed.
